

The Declaration of Intent to Administrate Phetchabun Primary Educational Service Area Office 1 with Honesty and Integrity

Phetchabun Primary Educational Service Area Office 1 (PBN 1) emphasizes on the management with integrity and transparency according to the intention of the Constitution of the Kingdom of Thailand, B.E.2560, Official Information Act B.E. 2540, Royal Decree on Criteria and Procedures for Good Governance, B.E.2546, National Anti-Corruption Strategy Phase 3 (B.E.2560 - 2564), and the 10<sup>th</sup> government policy on "Promotion on the governance administration with good governance and the prevention of corruption and misconduct in the government sector."


As the leader of the PBN 1, I would like to declare my intention to administer this organization in honesty, and transparency without corruption in order to be the standards, regulations and values for government officials and personnel to adhere and perform with other rules. I require government officials, personnel, and all schools which belong to PBN 1 perform as follows.

- 1. Working with good governance: We intend to work by focusing on the needs of people. We carry out our tasks with fast, accurate, equitable, transparent and fair service.
- 2. Working under the law strictly: We intend to perform every stage in accordance with law, regulations and rules completely, and strictly.
- 3. Indoctrinating values and attitudes: We require teachers to indoctrinate values and attitudes to students and personnel in schools to have knowledge, understanding, ethics, morality, and sufficiency economy philosophy, and adapt in their living lives.
- 4. Organizational Culture and Integrity: We will not tolerate any forms of corruption, against, and end up any corruption founds in our organization.
- 5. Cultivating and raising awareness: We require teachers to cultivate their students' awareness on corruption, and anti any forms of corruption around them.
- 6. Transparency: We are required to reveal information regarding the implementation of official tasks and procurement, provide opportunities for the general public or stakeholders to participate in PPESA01's inspection, disclose information in all forms of activities, and establish a precise administration and management system in dealing with complaints.

- 7. Anti-Corruption: We intent to carry out our tasks honestly and refrain from using our positions for personal benefits such as bribery or special perks.
- 8. Coordinating and cooperating: We are willing to coordinate and cooperate with the Office of the National Anti-Corruption Commission (ONACC) in the implementation of National strategy on prevention and suppression of corruption, Phase 3 (B.E.2560 2564)
- 9. Complaining: People and stakeholders are able to make complaints, giving us clues of corruption, and information via PPESA01.
